*POSSIBLE SENSATIONS: When using the system you may notice a number of sensations that can vary for different individuals.*

- 1. Various tingling sensations in parts of the body.*
- 2. A shortness of breath during or towards the end of the session.*

- 4. Tiredness*

*These sensations generally only last a few minutes after the completion of the session. If at any time the need is felt to remove the feet from the footbath, the user should do so. You should wait 48 hours before attempting the footbath again.*

*Children six (6) years old and under are not recommended to use the Aqua Chi machine.*

### *RESTRICTIONS OF THE AQUA CHI*

- 1. Any individual that is pregnant or may be pregnant should not use the system.*
- 2. Any individual that has transplanted organs should not use the system.*
- 3. Any individual that has any implanted electronic device; (such as but not limited to a pacemaker) should not use the system.*
- 4. The system may only be used for a maximum period of 35 minutes per use.*
- 5. The system may only be used every other day.*
- 6. Only one individual may use the system during any session.*

*Pregnant women and/or people taking medications should consult with a health care professional and/or their medical doctor trained in its use to monitor results and/or prescribe a protocol before using this device. It is not recommended for people with pacemakers or organ transplants as not enough research has been done on these conditions.*
